1. The draft list of members eligible to cast vote is prepared on the basis of the Register of Members as furnished by the society.
2. The eligibility for being a Director in the Board of Directors of the society shall be guided by the WBCS Act, 2006 (Amended up to date) read with the WBCS Rules, 2011 (Amended upto date) and the Bye- Laws of the society.
3. Two seats for women and one seat for SC/ST candidates shall be reserved on the Board in terms of the provisions existing Rules & Regulations and the 97th Amendment of the Constitution of India.
4. Every voter must produce document in support of her identity as prescribed by CEC Regulations, 2012.
5. Nominations filed against seats reserved for SC/ST candidates shall be supported by photocopy of certificate/ documents issued by appropriate authority. Originals are required to be produced at the time of scrutiny.
6. Nomination of a member willing to contest shall be submitted in Form- X as prescribed in terms of Rule 40(7)(i) of the WBCS Rules, 2011.
